We would like to inform all concerned areas that the presentation of the International Certificate of Vaccination by passengers is mandatory in some of TAAG – Angola Airlines operated destinations. Kindly note that it is required and mandatory for foreign passengers coming in to Angola to present their International Certificate of Vaccination (yellow fever).

Passengers in (transfer) transit through Angola, for less than 12 hours and who do not leave the air side, are not obliged to present their International Certificate of Vaccination in Angola. However it can be requested at the final destination of the passenger, as shown in the tables below.
